Greetings Residents, Families and Team Members,

As you have come to expect, we are keeping our promise to our Rosewood Village Greenbrier family by informing you about the evolving Covid-19 status in our community. Here is the most updated information as of today. Unfortunately, we report that after having one resident and team member testing positive for Covid-19, we did our due diligence in ensuring our residents and team members are continually safe by further testing. The testing yielded positivity for twenty-one residents on our Innovations Unit, but no other team members assessed positive.

While this is an exorbitant number of cases, we are so pleased to report that out of the twenty-one positive cases, only five residents had mild to moderate symptoms. All others exhibited no symptoms at all. We are on an "outbreak" status as specified by the Center for Disease Control (CDC) and have implemented appropriate protocol. The Innovations Unit team members are available and gearing up with personal protective equipment (PPE) as per protocol. Our Innovations nonpositive residents and our team members are to be retested in five days and after which five days. If all are negative, then the "outbreak" will be deemed lifted. If not, then five days will continue to be the retesting time until no positive testing.

Please know that the health department has advised that no other residents at Rosewood Village Greenbrier is required to be tested unless there are symptoms exhibited. We are happy, at your request, to assess those not requiring testing if you so desire. We do, however, continue mandating that any visitor visiting the residents who are positive, utilize the personal protective equipment that we have prepared for you. For those residents who are not positive, there remains no change to visitation.

Further, we inform you that our nonpositive residents are continuing to:
